

Henry Schein Events Terms and Conditions

Registration: All applications to register for the Henry Schein (HS) Events are subject to availability and you making full payment.

Henry Schein reserves the right to refuse any application to register, attend or participate at the Event/s. Henry Schein's decision is final and not subject to challenge. Henry Schein is not required to provide reasons for refusal of an application.

All fully paid registrations may be transferable to other persons from the same member organisation. Transfer requests must be made in writing to the Henry Schein contact information stated below and include the full name of replacement person, their title, contact phone number and email address. All other registration details will be assigned to the new person unless otherwise specified.

Delegate passes: Delegate passes issued for use at the Events are valid for the named attendee only. You may be asked for photographic ID during the event. If you are unable to provide identification which matches your Delegate pass you may be asked to leave the event.

Prices and payment: Our prices for attending the events are set out on the relevant online registration booking form or can otherwise be obtained from Henry Schein upon request or from our website. Prices may be subject to change from time to time.

Payment is required in full and up-front. A confirmation email and Tax Invoice will be sent upon receipt of registration. If full payment has not been received delegates will not be able to join the event.

Further copies of Tax Invoices will be provided at Henry Schein's discretion.

Cancellation policy: If you can no longer attend the event for any other reason including personal reasons or you change your mind, you may cancel your registration by providing written notice in an email to events@henryschein.com.au Henry Schein's refund policy is as follows:

- Cancellations made in writing received 30 days prior to the event will receive refund of registration fee less a 10% administration fee
- Cancellation made in writing received 15 days prior event will receive a 50% refund of registration fee
- Cancellation made in writing received before 7 days of an event will receive 25% refund of registration fee.

Cancellation made less than 7 days will not be entitled to any refund if the reason is change of mind.
